being the Approved Budget for the Contract (ABC) to payments under the contract for *CY 2020 BEFF REPAIR AND REHABILITATION OF SCHOOL BUILDINGS– SAVINGS (NOVEMBER 2020)* with bid ID number 275681. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Department of Education Schools Division of Isabela* now invites bids for the above Procurement Project. Completion of the Works is required *90 days after the receipt of the Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Department of Education Schools Division of Isabela* and inspect the Bidding Documents at the address given below from *8:00am – 5:00pm*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *December 4, 2020* from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the*

amount of Five Thousand Peoso(P 5,000.00).The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

The *Department of Education Schools Division of Isabela* will hold a Pre-Bid Conference¹ on *December 4, 2020 at 9:00 am at Deped School Division Office of Isabela Conference Hall, Alibagu, City of Ilagan, Isabela* and/or through videoconferencing/webcasting via *google meet through the link <https://meet.google.com/dae-ypiy-nre>*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *December 17, 2020 at 9:00 am*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on *December 17, 2020 at 9:00 am* at the given address below . Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *Department of Education Schools Division of Isabela* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
