REGISTRY OF QUALIFIED APPLICANTS FOR SCHOOL YEAR 2021-2022

1. It is emphasized that RA No. 8190, otherwise known as Localization Law, be strictly implemented in hiring permanent teachers, substitute and locally funded teachers, considering DepEd Order No. 7, s. 2015 re: Hiring Guidelines for Teacher I positions effective SY 2015-2016 and DepEd Order No. 9, s. 2016 re: Reiteration of DepEd Order Nos. 7 and 22, s. 2015 as The Hiring Guidelines For Kindergarten to Grade 10 Teaching positions.
2. This Division further cites the provision of Republic Act No. 7836 (Teacher Professionalization Law) in the hiring of permanent, substitute, casual, provisional, and local school board teachers particularly Section 26 par. 1 which states that “No person shall engage in teaching and/or act as a professional teacher as defined in this Act, whether in the preschool, elementary or secondary level, unless he is a duly registered professional teacher, and a holder of valid certificate of registration and a valid professional license or a holder of a valid special, temporary permit.”
3. A PDF Copy of the Registry of Qualified Applicants (RQA) for SY 2021-2022 and individual Certificate of Rating for Kindergarten and Elementary shall be sent through email to the District Supervisors and DICs, Junior High School (JHS) and Senior High School (SHS) to the Secondary School Heads respectively. The RQA shall be used as reference in proposing and appointing permanent and substitute teachers as well as locally-funded teachers such as PSB and LSB for natural vacancies and new teaching items. The said RQA is classified by District in the Elementary, congressional area and by subject area and/or specialization for JHS, and by Group in the SHS
