1. The *Department of Education Schools Division of Isabela*, through the FY 2020 GAA to apply the sum of *Seventeen Million Three Hundred Four Thousand Three Hundred-Ten and 29/100 pesos (Php 17,304,310.29)*

being the Approved Budget for the Contract (ABC) to payments under the contract for *FY 2021 LAST MILE SCHOOLS PROGRAM IN PUBLIC ELEMENTARY AND JUNIOR HIGH SCHOOL* with bid ID number 2021-08-02. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Department of Education Schools Division of Isabela* now invites bids for the above Procurement Project. Completion of the Works is required *120 days after the receipt of the Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Department of Education Schools Division of Isabela* and inspect the Bidding Documents at the address given below from *8:00am – 5:00pm*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *August 26, 2021* from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the*

amount of Twenty Five Thousand Pesos(P 25,000.00).The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

6. The *Department of Education Schools Division of Isabela* will hold a Pre-Bid Conference¹ on *August 26, 2021 at 9:00 am* through videoconferencing via *google meet through the link <https://meet.google.com/mqd-ndmg-oms>*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *September 8, 2021 at 9:00 am*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on *September 8, 2021 at 10:00 am* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *Department of Education Schools Division of Isabela* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
