

**SUBJECT: SIMULTANEOUS INAUGURATION OF SCHOOL MEDICAL/
DENTAL CLINICS AND LAUNCHING OF SDHP UNDER OPLAN
KALUSUGAN (OK) SA DEPED ONE HEALTH WEEK**

1. The Schools Division Office through the SGOD-School Health Section will join the nationwide celebration of the **OK sa DepEd One Health Week** on September 6-11, 2021.
2. As part of the celebration, a simultaneous inauguration of the Medical/Dental Clinics and Launching of the School Health Dental Program (SHDP) in identified schools on September 6, 2021, from 8:00 to 9:00 AM. Other activities to be undertaken shall include:

 - b. Ceremonial opening and ribbon cutting of the new school clinic
 - c. Blessing of the new school clinic (optional)
3. Identified participants in the said activity are PSDS, School Head, District Dentist, and District Nurse in every school/clinic. All participants shall strictly observe the minimum health protocols at all times. Schools with clinics that are currently used as COVID quarantine or isolation facilities are strictly not allowed to join the activity for safety reasons.
