**INVITATION TO BID FOR *PROCUREMENT OF NUTRITIOUS FOOD PRODUCTS FOR THE SCHOOL BASED FEEDING PROGRAM (FRESH EGGS) REBID***


1. The *Department of Education-Schools Division of Isabela*, through the *FY 2021 GAA* intends to apply the sum of *One Million Seven Hundred Sixteen Thousand Forty-Eight Pesos (Php 1,716,048.00)* being the ABC to payments under the contract for *Project Identification Number 2021-10-07*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Department of Education-Schools Division of Isabela* now invites bids for the above Procurement Project. Delivery of the Goods is required by *November 2021 to January 2022*. Bidders should have completed at least one (1) contract that is equivalent to at least twenty-five percent (25%) of the ABC similar to the Project. . If the bidder has no single contract equivalent to 25% of the ABC, bidder should have completed at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least 25% of the ABC and the largest of these similar contracts must be equivalent to at least half of the 25% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *Department of Education-Schools Division of Isabela* and inspect the Bidding Documents at the address given below during *8:00am to 5:00pm*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *October 9, 2021 to October 27, 2021* from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees and will be presented in person or through electronic means.

6. The *Department of Education-Schools Division of Isabela* will hold a Pre-Bid Conference<sup>1</sup> on **October 27, 2021 at 9:30 AM** through video conferencing or webcasting **via google meet with the link <https://meet.google.com/mqd-ndmg-oms>**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **October 27, 2021 9:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **October 27, 2021 at 10:45 AM** at the given address below **SDO Isabela Conference Hall, Alibagu, City of Ilagan, Isabela** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. During the opening of Bids, prospective bidders or their authorized representative are required to present their health declaration certificate duly signed by the Municipal Health Officer of their originating Municipality/City. Prospective Bidders are also required to wear face mask, face shield, and maintain social distancing at all times within and at the premises of the Division Office.
11. The *Department of Education-Schools Division of Isabela* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
