CLARIFICATION

This is to inform the field offices about some details pertaining to the PNU - LISQuP

First, NEAP Central Office has informed the field, through the NEAP - Regional Offices, that the deadline for the submission of requests for withdrawal was last 15 October 2021.

Second, the costs of the PNU - LISQuP Courses are as follows:

MA Programs - PhP 120,000.00

PhD Programs - PhP 150,000.00

Third, all participants to the PNU - LISQuP Courses will be informed of the documentary requirements they need to submit, including the Scholarship Contract (Enclosure). DepEd Memo No. 082, s. 2020). This same document contains the provision under the Duties of the Participant, Item C, that the participant "shall refund in full to DepEd such sums of money as may have been defrayed by the Philippine Government for expenses incidental for having attended the program or course, for failure to comply with any of the foregoing conditions through my fault or willful neglect, resignation from the service, transfer to other agencies, voluntary retirement or other causes within my control. For reasons beyond the control of the teacher-participant, the conditions do not apply, provided that all documentary requirements including doctor's certification are met and are acceptable to DepEd."

Hence, all requests for withdrawal submitted after the stated deadline and found without justifiable grounds with reference to the aforesaid provision, shall be subjected to the penalties mentioned. This is to afford the replacement participants with the sufficient time to join their classes and not cause them anymore missed lessons.
